Privacy Policy

This Privacy Policy pertains to the disclosure of the privacy practices <http://twogrannys.com/>. It applies solely to the user's personal information collected by this site. It outlines information which answers some of the issues concerning the protection of the data subject's information as follows:

1. What personal identifiable information we ask you to provide, how we treat such information, and with whom such identifiable information may be shared with.
2. What available choices are in place regarding the fundamental types of your personal data.
3. The assigned security procedures or measures in place designed to help at peace of your information.
4. How you can solve any conflicts regarding any inaccuracies in the information.

If you are located in any of the European countries, you will be required to provide clear and unambiguous affirmative consent indicated in an intelligent and easily accessible form using clean and plain language as provided under Article 7 (Conditions for Consent) of the General Data Protection Regulation (GDPR). Such consent is required for your protection in terms of the processing of your personal information via cookies and other equally applicable technologies.

As an EU user, this Privacy Policy is designed to allow you to freely access our Site as part of our compliance with the Regulation (EU) 2016/679 GDPR of the European Parliament and of the Council of the European Union which was approved and adopted on 27 April 2016. It became a binding legislative act effective 25 May 2018. As part of our compliance, we take appropriate measures to protect the fundamental rights and freedoms of EU data subjects.

Collecting, Using, and Sharing of Information

The processing of your data consists of collecting, using, and sharing of your information which you give us freely via email address and other direct contacts from you. For your privacy and security, we will not use your information to transact business with any third party, to the exception of requesting an order to be delivered. We will use your information to respond to your queries.

We value your loyalty, thus assuring you that we will let you know of any updates including specials, new products, or services.

Your Access to and Control over Information

You can do the following activities at any time by contacting us via the email address given on our site to, opting up when no longer necessary:

- Verify what data we have about you, if any.
- Change any data you provided.
- Have us delete any data you provided.
- Petition if unlawful use of data.

Security

We value your security against unlawful use of your information. Wherever we collect your credit card data and other sensitive information the same are encrypted and transmitted to us through a secure way. We recommend that you can verify this through looking for a closed lock icon located at the bottom of your web browser. You can also check by looking for "https" at the beginning of the address of the web page. Using an encryption is our way of protecting sensitive information transmitted both online and offline.

Accessing the personal identifiable information of the user can be extended to those employees who are tasked to do accounting and customer service tasks such as billing, customer service, and the like. One of their scopes of work is to ensure that they are kept in a secure environment.

Cookies

We use "cookies" on this site. For purposes of knowing the technical definition of a cookie, it is considered as a piece of data stored on a site visitor's hard drive. It is designed for purposes such as helping us improve your access to our site as well as identifying repeat visitors to our site. For example, when using a cookie to identify you, no more logging in a password more than once in order to save time while on our site. Through the use of cookies, we can also enable us to track as well as target our users' interests leading to enhancing the experience on our site. The use of a cookie is not linked to any personally identifiable information stored on our site.

Bases for the Disclosure of the User Information

If required by law, Two Granny's with a Broom may disclose your personal data information.
